



year ended 31 March 截至三月三十一日止年度 After the announcement of the 2015 Paris Climate Conference, energy saving products and services market has been one of the focus industries. Synergy Group, being an early entrant in provision of energy saving solutions, is well-positioned to further enhance both our local and global presence.

On behalf of the board of Directors (the "**Board**") of Synergy Group Holdings International Limited (the "**Company**"), I am pleased to report to our valued shareholders and investors the results of the Company and its subsidiaries (collectively referred to as the "**Group**") for the financial year ended 31 March 2016.

After the announcement of the 2015 Paris Climate Conference, there has been an increase in the awareness of environmental protection and demand for energy saving products, especially in some Asian developing countries. Recently, energy saving products and services market has been one of the focus industries, mainly because of the growing concern of the public on environmental protection due to severer climate change and higher operating costs suffered by most corporations due to the expected increasing electricity prices.

We are one of the leading energy management contract providers for lighting projects in Hong Kong, with full range capabilities on providing a broad range of energy saving services for lighting solutions, product customisation, on-site inspection and measurement, project deployment and after-sales services. 本人謹代表滙能集團控股國際有限公司(「本 公司」)董事會(「董事會」)欣然向各尊貴的 股東及投資者報告本公司及其附屬公司(統稱 「本集團」)截至二零一六年三月三十一日止財 政年度之業績。

二零一五年巴黎氣候會議公佈後,環保意識 有所加強,而對節能產品的需求亦有所上 升,尤其是於若干亞洲的發展中國家。近 期,節能產品及服務市場成為其中一個重點 行業,此乃主要由於氣候變化加劇令環境保 護問題日益備受公眾關注,及大部份企業因 預期電費上升而面對更高的營運成本所致。

我們為香港領先的照明項目能源管理合約供 應商之一,於照明解決方案、產品訂造、實 地檢查及量度、項目部署以及售後服務方 面,擁有全面提供廣泛節能服務的能力。 二零一五年巴黎氣候會議公佈 後,節能產品及服務市場成為其 中一個重點行業。滙能集團作為 提供節能解決方案的早期市場參 與者,在進一步發展本地及全球 業務方面佔有優勢。

For the year ended 31 March 2016, the Group recorded a total revenue of HK\$130.1 million, representing an increase of 16.7% as compared to HK\$111.5 million for the year ended 31 March 2015. For the year ended 31 March 2016, profit attributable to the owners of the Company amounted to HK\$35.4 million, representing an increase of 35.0% as compared to the corresponding amount of HK\$26.2 million for the year ended 31 March 2015.

For the year ended 31 March 2016, the Group has been successful in expanding its leasing business; and it has also expanded its leasing business into the Indonesian market. As a result, revenue generated from our leasing service segment increased by 142.1% from HK\$8.8 million for the year ended 31 March 2015 to HK\$21.4 million for the year ended 31 March 2016, while both of our trading segment and consultancy service segment had a steady growth.

Benefiting from the increasing awareness of energy saving products and services globally, the Group, being an early entrant in provision of energy saving solutions, is well-positioned to further enhance both our local and global presence. 截至二零一六年三月三十一日止年度,本集 團錄得總收入130.1百萬港元,較截至二零一 五年三月三十一日止年度的111.5百萬港元增 加16.7%。截至二零一六年三月三十一日止 年度,本公司擁有人應佔溢利達35.4百萬港 元,較截至二零一五年三月三十一日止年度 相關金額26.2百萬港元增加35.0%。

截至二零一六年三月三十一日止年度,本集 團成功擴充其租賃業務,亦將其租賃業務擴 充至印尼市場。因此,我們的租賃服務分部 產生的收入由截至二零一五年三月三十一日 止年度的8.8百萬港元增加142.1%至截至二 零一六年三月三十一日止年度的21.4百萬港 元,而我們的貿易分部及諮詢服務分部均穩 定增長。

本集團作為提供節能解決方案的早期市場參 與者,受惠於全球對節能產品及服務之日益 關注,在進一步發展本地及全球業務方面佔 有優勢。

Business Review

For the year ended 31 March 2016, we had a record of success in our leasing service segment. This was attributable to the effort we put forth in expanding into the overseas market, in view of the increase in the awareness of environmental protection and growing demand for energy saving products in developing countries in order to meet the emission reduction targets.

Revenue generated from our leasing service segment increased by 142.1% from HK\$8.8 million for the year ended 31 March 2015 to HK\$21.4 million for the year ended 31 March 2016 due to the energy management contracts under lease arrangement that were entered during the current year were of larger contract amounts and of contributions from businesses generated from overseas markets. Revenue generated from our trading segment increased by 5.4% from HK\$74.9 million for the year ended 31 March 2015 to HK\$78.9 million for the year ended 31 March 2016 due to the increase in sales of LED products, while revenue generated from our Consultancy Services (as herein after defined) segment for the year ended 31 March 2016 increased by 7.1% to HK\$29.8 million from HK\$27.8 million for the year ended 31 March 2015 due to the increase in resources we placed in such segment such as additional staff employed.

Details of segment information are set out in Note 6 to the consolidated financial statements.

Key Financial Ratios

業務回顧

截至二零一六年三月三十一日止年度,我們 的租賃服務分部取得成功。此乃歸因於我們 鑒於發展中國家為達到減排目標,環保意識 不斷增強及對節能產品的需求不斷增加,致 力擴充海外市場所致。

自我們的租賃服務分部產生的收入由截至二 零一五年三月三十一日止年度的8.8百萬港元 增加142.1%至截至二零一六年三月三十一日 止年度的21.4百萬港元,乃由於本年度訂立 合約金額較大的租賃安排下的能源管理合約 及海外市場業務作出的貢獻所致。自我們的 貿易分部產生的收入由截至二零一五年三月 三十一日止年度的74.9百萬港元增加5.4%至 截至二零一六年三月三十一日止年度的78.9 百萬港元,乃由於LED產品銷售增加所致,而 自我們的諮詢服務(定義見下文)分部產生的 收入則由截至二零一五年三月三十一日止年 度的27.8百萬港元增加7.1%至截至二零一六 年三月三十一日止年度的29.8百萬港元,乃 由於我們投放更多資源於有關分部,例如聘 請額外員工所致。

Principal Risks and Uncertainties

- Our consultancy services (the "Consultancy Services"), which are provided by the Group to third parties in assisting them in providing energy saving services in their markets, provided to our customers were project-based and demand for our Consultancy Services may fluctuate.
- We rely on our sub-contractors for providing services of deployment and installation of lighting products to customers.
- We rely on our key management to conduct the Group's business and the inability to retain or attract senior management personnel will adversely affect our performance.
- There may be changes in consumer preferences and habits in green technologies.

Financial Review

Total revenue was HK\$130.1 million for the year ended 31 March 2016, representing a 16.7% increase as compared to that for the year ended 31 March 2015. There has been an increasing demand for the Group's energy saving products and services. Gross profit margin decreased from 57.3% for the year ended 31 March 2015 to 53.2% for the year ended 31 March 2016. Such decrease was mainly due to an increase in revenue generated from the leasing service segment of which the leasing services in our newly developed overseas market had a relatively lower gross profit margin than other markets.

Other income and gains, which mainly consisted of a monthly service fee of HK\$150,000 received from an associate of our Group, increased from HK\$1.9 million for the year ended 31 March 2015 to HK\$2.2 million for the year ended 31 March 2016 mainly due to the reversal of warranty provision upon expiry.

Selling and Distribution Costs

The Group's selling and distribution costs for the year ended 31 March 2016 were HK\$4.6 million, representing an increase of 66.2% from HK\$2.8 million for the year ended 31 March 2015. The increase was mainly due to the increase in salaries and the increase in marketing activities such as participation in Eco Expo Asia 2015 and sponsoring a luncheon in relation to sustainable energy future that was held by World Green Organisation.

- 我們倚賴我們的主要管理層進行本集團 的業務,而未能挽留或吸引高級管理層 人員將對我們的表現造成不利影響。
- 客戶對綠色科技的偏好及喜好可能有變。

財務回顧

截至二零一六年三月三十一日止年度的總收 入為130.1百萬港元,較截至二零一五年三月 三十一日止年度增加16.7%。市場對本集團的 節能產品及服務的需求日益增加。毛利率由 截至二零一五年三月三十一日止年度的57.3% 下跌至截至二零一六年三月三十一日止年度 的53.2%。該跌幅主要由於租賃服務分部所產 生的收入增加,而當中我們新發展的海外市 場的租賃服務毛利率相對低於其他市場所致。

主要包括收取來自本集團聯營公司的每月服 務費150,000港元的其他收入及收益由截至二 零一五年三月三十一日止年度的1.9百萬港元 增加至截至二零一六年三月三十一日止年度 的2.2百萬港元,主要由於保修撥備於到期後 撥回所致。

銷售及分銷成本

截至二零一六年三月三十一日止年度,本集 團的銷售及分銷成本為4.6百萬港元,較截至 二零一五年三月三十一日止年度的2.8百萬港 元增加66.2%。該增加主要由於薪金上升及舉 辦更多營銷活動所致,例如參與二零一五年 國際環保博覽及贊助由世界綠色組織舉辦有 關可持續能源未來的午宴。

Administrative Expenses

The Group's administrative expenses for the year ended 31 March 2016 were HK\$15.6 million, representing a decrease of 29.8% from HK\$22.2 million for the year ended 31 March 2015. The decrease was mainly due to the net effect of the decrease in listing related professional expenses and the increase in salaries (including directors' remuneration) and overseas travelling expenses as a result of the expansion of our Group's business.

Finance Costs

The Group's finance costs increased from approximately HK\$13,000 for the year ended 31 March 2015 to approximately HK\$421,000 for the year ended 31 March 2016. The increase was due to the interest expenses arising from the new bank borrowings drawn down of HK\$25.3 million during the year.

Other Expenses

The Group's other expenses increased to HK\$1.5 million for the year ended 31 March 2016 from HK\$1.1 million for the year ended 31 March 2015. Such expenses were mainly derived from the disposal of property, plant and equipment during the year.

Income Tax Expense

The Group's income tax expense for the year ended 31 March 2016 was HK\$9.2 million, representing a decrease of 6.3% from HK\$9.8 million for the year ended 31 March 2015. The decrease was mainly due to the decrease in deferred tax.

Profit for the Year

As a result of the foregoing, our profit attributable to the owners of the Company increased by 35.0% from HK\$26.2 million for the year ended 31 March 2015 to HK\$35.4 million for the year ended 31 March 2016. Excluding the non-recurring listing-related expenses, our profit for the year ended 31 March 2016 recorded as HK\$35.4 million, representing a 15.4% decrease as compared to HK\$41.9 million for the year ended 31 March 2015.

行政開支

截至二零一六年三月三十一日止年度,本集 團的行政開支為15.6百萬港元,較截至二零 一五年三月三十一日止年度的22.2百萬港元 減少29.8%。該減少主要由於與上市有關的專 業費用減少以及薪金(包括董事酬金)增加及 因本集團業務擴展而令海外差旅開支增加的 淨影響所致。

融資成本

本集團的融資成本由截至二零一五年三月三 十一日止年度的約13,000港元增加至截至二 零一六年三月三十一日止年度的約421,000 港元。該增加主要由於年內提取新銀行借款 25.3百萬港元產生的利息開支所致。

其他開支

本集團的其他開支由截至二零一五年三月三 十一日止年度的1.1百萬港元增加至截至二零 一六年三月三十一日止年度的1.5百萬港元。 該等開支主要來自年內出售物業,廠房及設 備。

所得税開支

截至二零一六年三月三十一日止年度,本集 團的所得税開支為9.2百萬港元,較截至二零 一五年三月三十一日止年度的9.8百萬港元下 跌6.3%。跌幅乃主要由於遞延税項減少所致。

年內溢利

鑒於前述,本公司擁有人應佔溢利由截至二 零一五年三月三十一日止年度的26.2百萬港 元上升35.0%至截至二零一六年三月三十一日 止年度的35.4百萬港元。撇除非經常性上市 相關費用,截至二零一六年三月三十一日止 年度錄得35.4百萬港元的溢利,較截至二零 一五年三月三十一日止年度的41.9百萬港元 下跌15.4%。 The following table reconciles our net profit (before deducting listing-related expenses) for the years presented to the audited profit for the years indicated:

Note: The decrease was mainly due to the increase in post-listing expenses of more than HK\$2.4 million and the increase in administrative expenses such as travelling expenses as a result of further expansion of the Group's business. Potential investors should be aware that this net profit for the year (before deducting listing-related expenses) presented in this report may not be comparable to similar titled measures reported by other companies due to differences in the components of the calculations.

Liquidity and Financial Resources

The shares of the Company were listed on GEM on 24 March 2015 (the "**Listing**").

The Group mainly finances its business with internally generated cash flows, bank borrowings and proceeds from the Listing. As at 31 March 2016, currents assets of the Group amounted to HK\$148.4 million, representing an increase of 46.0% from HK\$101.7 million as at 31 March 2015. Current assets mainly comprised cash and bank balances (including pledged bank deposits) of HK\$29.1 million (2015: HK\$27.7 million) and trade receivables of HK\$84.9 million (2015: HK\$58.6 million).

As at 31 March 2016, the Group's current liabilities mainly comprised borrowings of HK\$25.3 million (2015: HK\$0.1 million), trade payables of HK\$16.3 million (2015: HK\$6.4 million) and accruals, other payables and deposits received of HK\$7.3 million (2015: HK\$6.8 million).

附註:該減少主要由於上市後費用增加超過2.4百萬港元及 因本集團業務進一步擴充而令行政開支(例如差旅開 支)增加所致。潛在投資者應留意,由於計算的組成 部份有所不同,本報告中呈列的年內淨溢利(扣除上 市相關費用前)未必可與其他公司報告的類似項目的 計量可資比較。

流動資金及財務資源

本公司股份於二零一五年三月二十四日於創 業板上市(「**上市**」)。

本集團主要以內部產生之現金流、銀行借款 及上市所得款項撥支其業務。於二零一六年 三月三十一日,本集團的流動資產達148.4 百萬港元,較於二零一五年三月三十一日的 101.7百萬港元增加46.0%。流動資產主要由 現金及銀行結餘(包括已抵押銀行存款)29.1 百萬港元(二零一五年:27.7百萬港元)以及 貿易應收賬款84.9百萬港元(二零一五年: 58.6百萬港元)組成。

於二零一六年三月三十一日,本集團的流 動負債主要由借款25.3百萬港元(二零一五 年:0.1百萬港元)、貿易應付賬款16.3百萬 港元(二零一五年:6.4百萬港元)以及應計 費用、其他應付款項及已收按金7.3百萬港元 (二零一五年:6.8百萬港元)組成。 The Group's current ratio decreased from 4.9 times as at 31 March 2015 to 2.6 times as at 31 March 2016. The Group has sufficient working capital to meet the current liquidity demand within at least 12 months from the date of this report.

The total outstanding borrowings of the Group as at 31 March 2016 was HK\$25.5 million (31 March 2015: approximately HK\$449,000) due to banks and an independent third party. The increase was due to the new bank borrowings of HK\$25.3 million that was drawn during the year.

As at 31 March 2016, the Group's equity attributable to the owners of the Company was HK\$132.2 million, representing an increase of 36.5% from HK\$96.9 million as at 31 March 2015.

As at 31 March 2016, a time deposit of HK\$2.5 million was pledged as a security for the bank facilities (31 March 2015: Nil). Save as disclosed above, the Group has no other charges on its assets as at 31 March 2016.

Contingent Liabilities

The Group had no significant contingent liabilities as at 31 March 2016.

Associated Company

Synergy Cooling Management Limited ("**SCML**", together with its subsidiaries, the "**Cooling Group**") is an associated company of the Group which was owned as to approximately 27.17% (subsequently increased to approximately 36.59% and details are set out in the paragraph below) by the Group. SCML wholly owns Synergy Cooling Management (H.K.) Limited ("**SCML (HK)**") and indirectly wholly owns Synergy ESCO (Malaysia) Sdn. Bhd. ("**SE (Malay)**"). Both SCML (HK) and SE (Malay) are principally engaged in the business of energy saving management. 本集團的流動比率由二零一五年三月三十一 日的4.9倍下降至二零一六年三月三十一日的 2.6倍。本集團擁有充足的營運資金以應付其 目前於本報告日期起計最少12個月內的流動 資金需求。

本集團於二零一六年三月三十一日的未償還 予銀行及一名獨立第三方的借款總額為25.5 百萬港元(二零一五年三月三十一日:約 449,000港元)。該增加乃由於年內提取的新 銀行借款25.3百萬港元所致。

於二零一六年三月三十一日,本集團的本公 司擁有人應佔權益為132.2百萬港元,較於二 零一五年三月三十一日的96.9百萬港元增加 36.5%。

於二零一六年三月三十一日,一筆定期存款 2.5百萬港元已抵押為銀行融資的保證金(二 零一五年三月三十一日:無)。除上文披露者 外,於二零一六年三月三十一日,本集團概 無就其資產作出任何其他押記。

或然負債

本集團於二零一六年三月三十一日並無重大 或然負債。

聯營公司

Synergy Cooling Management Limited (「SCML」,連同其附屬公司統稱「空調集 團」)為一間本集團的聯營公司,本集團擁有 其約27.17%權益(其後增加至約36.59%, 詳情載於以下段落)。SCML全資擁有滙能空 調管理(香港)有限公司(「SCML (HK)」)及 間接全資擁有Synergy ESCO (Malaysia) Sdn. Bhd.(「SE (Malay)」)。SCML (HK)及SE (Malay)均主要從事節能管理業務。 On 6 October 2015 (after trading hours), Synergy Group Worldwide Limited ("**Synergy Worldwide**") as a purchaser entered into the sale and purchase agreement with Fuqi Holdings Limited as a vendor pursuant to which Fuqi Holdings Limited agreed to sell, and Synergy Worldwide agreed to acquire, approximately 9.42% interest in SCML at a consideration of HK\$19.5 million. The acquisition was completed on 8 October 2015 and upon completion, Synergy Worldwide has become interested in approximately 36.59% in SCML. Details of the acquisition are set out in the announcements of the Company dated 6 October 2015 and 14 October 2015.

The turnover of the Cooling Group for the year ended 31 March 2016 was HK\$9.6 million, representing an increase of 58.7% from HK\$6.1 million for the year ended 31 March 2015. It was mainly attributable to the incorporation of SE (Malay) during the year ended 31 March 2015 in accordance with Cooling Group's expansion strategy. The net loss attributable to the shareholders of the Cooling Group for the year ended 31 March 2016 was HK\$13.3 million which remained stable as compared to HK\$13.3 million for the year ended 31 March 2015.

During the year, the Group made advances of HK\$5.2 million to the Cooling Group at interest rate of 5% per annum.

Save as disclosed above, there were no other significant investments held, material acquisition or disposal of subsidiaries and affiliated companies, and other plans for material investments or capital assets during the year ended 31 March 2016.

Guarantees

During the year, a Hong Kong subsidiary of the Group has committed to provide corporate guarantees to two independent third parties in Malaysia in respect of equipment lease agreements entered into between the independent third parties and an associate of the Group. The duration of the agreements were ranging from 48 months to 59 months, with average monthly rent charged to the associate of approximately RM23,000 each (equivalent to approximately HK\$46,000 each).

Save as disclosed above, we did not have any material guarantees as at 31 March 2016.

於二零一五年十月六日(交易時段結束後), 滙能集團環球有限公司(「**滙能環球**」)(作為 買方)與富祺控股有限公司(作為賣方)訂立 買賣協議,據此,富祺控股有限公司同意出 售而滙能環球同意收購SCML約9.42%權益, 代價為19.5百萬港元。該收購已於二零一五 年十月八日完成,於完成後,滙能環球持有 SCML約36.59%權益。收購事項的詳情載於 本公司日期為二零一五年十月六日及二零一 五年十月十四日之公告。

空調集團的營業額由截至二零一五年三月三 十一日止年度的6.1百萬港元增加58.7%至截 至二零一六年三月三十一日止年度的9.6百萬 港元。此乃主要歸因於SE (Malay)於截至二零 一五年三月三十一日止年度根據空調集團的 擴展策略而註冊成立所致。截至二零一六年 三月三十一日止年度,空調集團股東應佔淨 虧損為13.3百萬港元,與截至二零一五年三 月三十一日止年度的13.3百萬港元相比維持 穩定。

年內,本集團按年利率5%向空調集團墊款5.2 百萬港元。

除以上所披露者外,於截至二零一六年三月 三十一日止年度,本公司概無持有其他重大 投資、進行重大收購或出售附屬公司及聯屬 公司,亦無其他重大投資計劃或資本資產。

擔保

年內,本集團於香港之附屬公司已向兩名馬 來西亞獨立第三方承諾就該等獨立第三方與 本集團一間聯營公司所訂立之設備租賃協議 提供企業擔保。該等協議之期限介乎48個月 至59個月,而向聯營公司收取之平均月租約 為每名獨立第三方23,000令吉(相等於每名獨 立第三方約46,000港元)。

除上文所披露者外,於二零一六年三月三十 一日,我們並無擁有任何重大擔保。

Employees and Remuneration Policies

As of 31 March 2016, the Group had 27 full-time employees. The Group offers a competitive remuneration package commensurate with industry practice and provides benefits to its employees, including bonuses, medical coverage and provident fund contributions.

The Group has arranged for its Hong Kong employees to join the Mandatory Provident Fund (MPF) Scheme. Under the MPF Scheme, each of the Group companies (the employer) and its employees make monthly contributions to the scheme at 5% of the employees' earnings as defined under the Mandatory Provident Fund Legislation. The contributions from each of the employers and employees are subject to a cap of HK\$1,500 per month and thereafter contributions are voluntary.

The Company has adopted a share option scheme as an incentive to its Directors and eligible employees of the Group, details of which are set out in the paragraph headed "Share Option Scheme" below.

Share Option Scheme

A share option scheme (the "Share Option Scheme") adopted by the Company was approved by its shareholder on 5 March 2015. Unless otherwise cancelled or amended, the Share Option Scheme will remain in force for 10 years from 5 March 2015. Under the Share Option Scheme, the Directors may in its absolute discretion offer to grant to any qualified participant an option to subscribe for the number of shares at an exercise price determined by the Board, being at least the highest of (i) the closing price of shares of the Company as stated in the Stock Exchange's daily quotation sheets on the date of the offer of grant; (ii) the average of the closing prices of the shares of the Company as stated in the Stock Exchange's daily quotation sheets for the five business days immediately preceding the date of the offer of grant; and (iii) the nominal value of the shares of the Company. The offer of a grant of options may be accepted within 20 business days from the date of the offer. HK\$1.00 is payable by any qualified participant to our Company on acceptance of the option offer as consideration for the grant. Qualified participants include any Director or employee (whether full time or part time) of our Company and its subsidiaries and associated companies (as defined under the Companies Ordinance, Cap. 622 of the laws of Hong Kong).

僱員及薪酬政策

於二零一六年三月三十一日,本集團有27名 全職僱員。本集團向其僱員提供與行業慣例 相稱且具競爭力的薪酬待遇及福利,包括花 紅、醫療保險及公積金供款。

本集團已安排其香港僱員參加強制性公積金 (強積金)計劃。根據強積金計劃,本集團各 成員公司(僱主)及其僱員按強制性公積金 條例定義之僱員收入之5%每月向計劃作出供 款。僱主及僱員各自的供款均以每月1,500港 元為上限,其後作出之供款屬自願性質。

本公司已採納購股權計劃,用以激勵其董事 及本集團合資格僱員,其詳情載於下文「購股 權計劃」一段。

購股權計劃

本公司採納的購股權計劃(「購股權計劃」) 已於二零一五年三月五日獲其股東批准。除 非另行取消或修訂購股權計劃,否則購股權 計劃自二零一五年三月五日起生效,為期10 年。根據購股權計劃,董事可全權酌情向任 何合資格參與者授出購股權之要約,以供認 購特定數目的股份,行使價由董事會釐定, 並須為以下最高者:(i)本公司股份於授出要 約日期於聯交所每日報價表所列之收市價;(ii) 本公司股份緊接授出要約日期前五個營業日 於聯交所每日報價表所列之平均收市價;及 (iii)本公司股份的面值。參與者可於要約日期 起計20個營業日內接受授出的購股權要約。 任何合資格參與者接受購股權要約須向本公 司支付1.00港元,作為獲授購股權的代價。 合資格參與者包括本公司及其附屬公司及聯 營公司(定義見香港法例第622章《公司條 例》)的任何董事或僱員(不論全職或兼職)。

The options granted may be exercised in whole or in part by the grantees. The exercise period of the options granted shall be a period of time to be notified by the Directors to the grantees, which the Directors may in its absolute discretion determine, save that such period shall not be more than 10 years commencing on the date of the offer of grant.

The maximum number of shares issuable upon exercise of the options which may be granted under the Share Option Scheme and any other share option schemes of our Company (including both exercised and outstanding options) to each participant in any 12-month period shall not exceed 1% of the shares of the Company then in issue. Any further grant of share options in excess of this limit is subject to the Company's shareholders' approval in a general meeting.

The maximum number of shares in respect of which options may be granted under this Share Option Scheme and any other share option schemes of the Company shall not in aggregate exceed 10% of the total number of shares in issue as at the date which the Company's shares first commence trading on GEM, being 50,000,000 shares.

No share options were granted under the Share Option Scheme during the year ended 31 March 2016. As at 31 March 2016, there were no outstanding options granted under the Share Option Scheme. Share options do not confer rights to the holders to dividends or to vote at shareholders' meetings.

Capital Structure

The shares of the Company were listed on GEM of the Stock Exchange on 24 March 2015. The Group mainly finances its business with internally generated cash flows, bank borrowings and proceeds from the Listing. The Group has bank borrowings of HK\$25.2 million as at 31 March 2016 (31 March 2015: Nil). 承授人可行使全部或部份獲授予的購股權。 所授予的購股權行使期限可由董事全權酌情 釐訂並知會承授人,惟該期限不得超過自授 出要約日期起計10年。

於行使根據購股權計劃及本公司任何其他購 股權計劃可能授出的購股權後於任何12個月 期間可向各參與者發行的股份最高數目(包括 已行使及未行使的購股權)不得超過本公司當 時已發行股份的1%。凡進一步授出超過此限 額的購股權均須經本公司股東於股東大會上 批准。

根據此購股權計劃及本公司任何其他購股權 計劃可能授出的購股權所涉及的股份最高數 目合共不得超過本公司股份首次於創業板 開始買賣日期已發行股份總數的10%,即 50,000,000股股份。

截至二零一六年三月三十一日止年度概無根 據購股權計劃授出購股權。於二零一六年三 月三十一日,概無根據購股權計劃已授出之 購股權為尚未行使。購股權概無賦予持有人 收取股息或於股東大會上投票的權利。

資本架構

本公司股份於二零一五年三月二十四日於聯 交所創業板上市。本集團主要以內部產生的 現金流、銀行借款及上市所得款項為其業務 撥支。本集團於二零一六年三月三十一日的 銀行借款為25.2百萬港元(二零一五年三月三 十一日:無)

Foreign Currency Exposure

Our Group's revenue and expenses are mainly in Hong Kong dollar which is the functional currency of all entities making up the Group. Our Group is mainly exposed to the foreign currency risk of Renminbi, US dollar, Malaysian Ringgit and Indonesian Rupiah. As Hong Kong dollar is pegged to US dollar, we do not expect any significant movement in the US dollar/Hong Kong dollar exchange rate. For the sensitivity analysis of the Group's results for the year in regards to a 5% appreciation in Hong Kong dollar against the relevant foreign currencies, details are set out in note 35 to the consolidated financial statements in this Annual Report. The Group currently does not have hedging policy against foreign exchange risk. The management will consider hedging significant currency exposure in future should the need arises.

Gearing Ratio

As at 31 March 2016, the gearing ratio of the Group was 19.3% (31 March 2015: 0.5%), which is calculated on the basis of the amount of total debts divided by the total equity. Such increase was due to the new bank borrowings that were drawn down during the year.

Dividend

The Board did not recommend the payment of any dividend for the year ended 31 March 2016.

The Company is not aware of any arrangement under which a shareholder has waived or agreed to waive any dividends.

外幣風險

本集團的收入及開支主要以港元計值,港元 為組成本集團的所有實體的功能貨幣。本集 團主要面對人民幣、美元、馬來西亞令吉及 印尼盾的外幣風險。由於港元與美元掛鈎, 我們並不預期美元兑港元的匯率有任何重大 變動。有關港元兑相關外幣升值5%對本集團 年度業績之敏感度分析,詳情載於本年報綜 合財務報表附註35。本集團目前並無任何對 沖外匯風險的政策。管理層將於日後在有需 要時考慮對沖重大貨幣風險。

資本負債比率

於二零一六年三月三十一日,本集團的資本 負債比率為19.3%(二零一五年三月三十一 日:0.5%),此乃按總負債金額除以總權益之 基準計算得出。該增加乃由於年內提取新銀 行借款所致。

股息

董事會並不建議派付截至二零一六年三月三 十一日止年度的任何股息。

本公司並未注意到股東已放棄或同意放棄任 何股息的安排。

Future Outlook





EXECUTIVE DIRECTORS

Mr. Wong Man Fai Mansfield, aged 42, is our Chief Executive Officer, Chairman of the Board and an Executive Director. He is also a director of Synergy Lighting Limited and Synergy Group Worldwide Limited, both are wholly-owned subsidiaries of the Company, and was appointed as the Chief Executive Officer of Synergy Lighting Limited on 1 July 2009. He was appointed as a Director of our Company on 30 December 2011. He is primarily responsible for the overall corporate strategies, development management and operation of our Group. Mr. Wong graduated from the University of Arizona, Arizona, United States with a Bachelor's degree in Electrical Engineering in May 1996. He also obtained a Master of Engineering (Electrical) from Cornell University, New York, United States in May 1997. He has over 11 years of management experience. Mr. Wong is the sole director and sole shareholder of Mpplication Group Limited, which provides information technology management services to our Group. Mr. Wong is the sole director and sole shareholder of Abundance Development Limited and one of our substantial shareholders. Mr. WONG has been leading our Group as the Chief Executive Officer of the Company and one of our subsidiaries since 2009, thus, the Board believes that it is in the best interest of the Group to continue to have Mr. Mansfield WONG stav as the Chief Executive Officer and leader of the Board for effective management of our Group. The balance of power and authority is ensured by the operation of the senior management and the Board, which is comprised of experienced and high-calibre individuals. The Board currently comprises three Independent Non-executive Directors and has a fairly strong independence element in its composition. Therefore, the Board considers that the deviation from code provision A.2.1 is appropriate in the circumstances. The Board will review the management structure regularly and consider separating the roles of chairman and chief executive, if and when appropriate.

Throughout the year ended 31 March 2016 and up to the date of this Annual Report, the Board at all times complied with Rules 5.05(1) and (2), and 5.05A of the GEM Listing Rules relating to the appointment of at least three independent non-executive directors, representing at least one-third of the Board, with at least one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The Company has received the written confirmation from each of the Independent Non-executive Directors in respect of their independence pursuant to Rule 5.09 of the GEM Listing Rules. The Company is of the view that all Independent Non-executive Directors are independent in accordance with the independence guidelines as set out in the GEM Listing Rules.

Terms of Appointment and Re-Election of Directors

Each of the Executive Directors has entered into a service agreement with the Company for a fixed term commencement from 24 March 2015 (the "**Listing Date**") until and including the date of the third annual general meeting following the Listing Date and will continue thereafter until terminated by at least three months' written notice or payment in lieu to the other party. Each of the Non-executive Director and Independent Non-executive Directors has entered into an appointment letter with the Company with a term of three years commencing from the Listing Date.

According to the Company's article of association (the "Articles of Association"), at least one-third of the Directors for the time being shall retire from office by rotation, provided that every Director shall be subject to retirement at an annual general meeting at least once every three years.

Any director appointed to fill a casual vacancy shall hold office until the first general meeting of shareholders and be subject to re-election at such general meeting, and any director appointed as an addition to the Board will be subject to re-election by shareholders at the first annual general meeting after initial appointment.

Continuous Professional Development of Directors

Every Director keeps abreast of responsibilities as a Director of the Company and of the conduct, business activities and development of the Company.

Every newly appointed director would receive formal, comprehensive and tailored induction on the first occasion of his appointment to ensure appropriate understanding of the business and operations of the Group and full awareness of director's responsibilities and obligations under the GEM Listing Rules and relevant statutory requirements.

Directors should participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant. All Directors are encouraged to attend relevant training courses at the Company's expenses.

Agendas for each meeting are prepared by the Company Secretary in consultation with the Directors, and based on a forward calendar that helps ensure that all relevant matters for the year ahead are considered by the Board in a timely manner. All Directors are encouraged to contribute to the agenda setting process. Agendas and accompanying papers are sent to all Directors at least 3 days before each Board meeting or committee meeting for their review and to keep the Directors apprised of the latest developments and financial position of the Company so as to enable them to make informed decisions.

In addition to board papers, information relevant to the Company's financial position and latest developments is made available to Directors to keep them up to date. Structured monthly updates on the Company's performance, position and prospects are provided to Directors. The Directors also have access to the Company Secretary and senior management where necessary.

The Company Secretary is responsible to keep minutes of all Board meetings and committees meetings. Draft minutes are normally circulated to all Directors for comments within a reasonable time after each meeting and the final versions are open for Directors' inspection.

The primary duties of the Audit Committee are mainly to make recommendation to the Board on the appointment, re-appointment and removal of external auditor; review the financial statements and material advice in respect of financial reporting; and oversee financial reporting system, and risk management and internal control systems of our Company.

As at the date of this Annual Report, the Audit Committee comprises three Independent Non-executive Directors, namely Mr. CHUNG Koon Yan (Chairman of the Audit Committee), Mr. CHEUNG Yick Hung Jackie and Dr. WONG Chi Ying Anthony, with Mr. CHUNG possessing the appropriate professional qualifications and accounting and related financial management expertise.

The offer shall remain open for acceptance for a period of twenty business days from the date on which it is made. Subject to the terms of the offer letter, there shall be no general performance target to or minimum holding period for the vesting or exercise of options. An option shall be deemed to have been accepted and to have taken effect when the duplicate letter comprising acceptance of the option duly signed by the option-holder together with a remittance in favour of our Company of HK\$1.00 by way of consideration for the grant of the option shall have been received by our Company on or before the last day for acceptance as set out in the offer letter. The remittance is not in any circumstances refundable. Once accepted, the option is granted as from the date on which it was offered to the relevant Qualified Participant.

(d) Subscription Price

The subscription price ("**Subscription Price**") shall be a price determined by the Board but in any event shall be at least the highest of: (i) the closing price of the shares as stated in the Stock Exchange's daily quotations sheets on the date on which the option is offered to a Qualified Participant ("**Offer Date**"); (ii) the average of the closing prices of the shares as stated in the Stock Exchange's daily quotation sheets for the five business days immediately preceding the Offer Date; and (iii) the nominal value of the shares.

For the purpose of calculating the scheme mandate ("**Scheme Mandate**"), options which have been lapsed in accordance with the terms of the relevant scheme shall not be counted.

(f) Maximum entitlement of shares of each Qualified Participant

Unless approved by the shareholders of the Company in general meeting in the manner prescribed in the GEM Listing Rules, the Board shall not grant options to any option-holder if the acceptance of those options would result in the total number of shares issued and to be issued to that Qualified Participant on exercise of his options (including both exercised and outstanding options) during any 12-month period exceeding 1% of the total shares then in issue.

(g) Timing for exercise of options

The period during which an option may be exercised in accordance with the terms of the Share Option Scheme ("**Option Period**") shall be a period of time to be notified by the Board to each option-holder, which the Board may in its absolute discretion determine, save that such period shall not be more than ten years commencing on the Offer Date.

(h) Life of the Share Option Scheme

The Share Option Scheme shall be valid and effective for a period of ten years commencing from the date on which the Share Option Scheme is deemed to take effect in accordance with its terms, after which period no further options will be granted but the provisions of the Share Option Scheme shall remain in full force and effect in all other respects. 1. General information, reorganisation and basis of presentation

Synergy Group Holdings International Limited (the "Company") was incorporated as an exempted company with limited liability in the Cayman Islands on 14 December 2011. The address of the Company's registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The principal place of business of the Company is Room 404B, 4/F, Block B, Seaview Estate, Nos. 4-6 Watson Road, North Point, Hong Kong.

The principal activity of the Company is investment holding. Details of the principal activities of the Company's subsidiaries are set out in note 31 to the consolidated financial statements. The Company and its subsidiaries are collectively referred to as the "Group" hereafter.

In connection with the listing of the shares of the Company on the Growth Enterprise Market ("GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), the Company underwent a reorganisation (the "Reorganisation") and the Company has become the holding company of its subsidiaries now comprising the Group since 5 March 2015. The shares of the Company were listed on GEM on 24 March 2015.

Details of the Reorganisation are set out in the section headed "History and Corporate Development" to the prospectus of the Company dated 13 March 2015.

1. 一般資料、重組及呈列基準

General information, reorganisation and basis of presentation – Continued

Upon completion of the Reorganisation but before placing, the equity interest held by the Company's shareholders mirrored their respective percentage of equity interest in Synergy Group Worldwide Limited ("Synergy Worldwide") before the Reorganisation, where Synergy Worldwide was the then holding company of the Group. The Group is regarded as a continuation of Synergy Worldwide resulting from the Reorganisation as there is no change in the economic substance of the Group. Accordingly, the consolidated financial statements were prepared using the merger accounting and as if the current group structure had always been in existence. Accordingly, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows of the Group for the year ended 31 March 2015 include the results, changes in equity and cash flows of the companies now comprising the Group from the earliest date presented or since their respective dates of incorporation, whichever was shorter, as if the current group structure had been in existence throughout those years. The consolidated statement of financial position of the Group as of 31 March 2015 has been prepared to present the assets and liabilities of the companies now comprising the Group as if the current group structure had been in existence at that date. No adjustment is made to reflect fair values, or to recognise any new assets or liabilities as a result of the Reorganisation.

The consolidated financial statements for the year ended 31 March 2016 were approved and authorised for issue by the board of directors on 31 May 2016.

Amendments to HKAS 1 – Disclosure Initiative

The amendments are designed to encourage entities to use judgement in the application of HKAS 1 when considering the layout and content of their financial statements.

HKFRS 9 (2014) - Financial Instruments

HKFRS 9 introduces new requirements for the classification and measurement of financial assets. Debt instruments that are held within a business model whose objective is to hold assets in order to collect contractual cash flows (the business model test) and that have contractual terms that give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding (the contractual cash flow characteristics test) are generally measured at amortised cost. Debt instruments that meet the contractual cash flow characteristics test are measured at fair value through other comprehensive income ("FVTOCI") if the objective of the entity's business model is both to hold and collect the contractual cash flows and to sell the financial assets. Entities may make an irrevocable election at initial recognition to measure equity instruments that are not held for trading at FVTOCI. In addition, HKFRS 9 retains the requirements in HKAS 39 for derecognition of financial assets and financial liabilities.

The new standard establishes a single revenue recognition framework. HKFRS 15 includes specific guidance on particular revenue related topics that may change the current approach taken under HKFRS. The standard also significantly enhances the qualitative and quantitative disclosures related to revenue.

The Group is in the process of making an assessment of the potential impact of the above new/revised HKFRSs apart from HKFRS 16 and the directors so far concluded that the application of these new/revised HKFRSs will have no material impact on the Group's financial statements.

HKFRS 16 - Leases

HKFRS 16 supersedes HKAS 17 "Leases", HK(IFRIC) — Int 4 "Determining whether an Arrangement contain a Lease", HK(SIC) — Int 15 "Operating Lease — Incentives" and HK(SIC) — Int 27 "Evaluating the Substance of Transactions Involving the Legal Form of a Lease".

HKFRS 16 eliminates the classification by a lessee of leases as either operating or finance. Instead all leases are treated in a similar way to finance leases in accordance with HKAS 17 "Leases". Under HKFRS 16, leases are recorded on the statement of financial position by recognising a liability for the present value of its obligation to make future lease payments with an asset (comprised of the amount of lease liability plus certain other amounts) either being disclosed separately in the statement of financial position (within right-of-use assets) or together with property, plant and equipment. The most significant effect of the new requirements will be an increase in recognised lease assets and financial liabilities.

HKFRS 16 - Leases - Continued

There are some exemptions. HKFRS 16 contains options which do not require a lessee to recognise assets and liabilities for (a) short term leases (i.e. lease of 12 months or less, including the effect of any extension options) and (b) leases of low value assets (for example, a lease of a personal computer).

HKFRS 16 substantially carries forward the lessor's accounting requirements in HKAS 17. Accordingly, a lessor continues to classify its leases as operating leases or finance leases, and to account for those two types of leases differently. In classifying a sublease, an intermediate lessor shall classify the sublease as a finance lease or an operating lease as follows: (a) if the head lease is a short-term lease that the entity, as a lessee, the sublease shall be reclassified as an operating lease; (b) otherwise, the sublease shall be classified by reference to the right-of-use asset arising from the head lease, rather than by reference to the underlying asset.

HKFRS 16 clarifies that a lessee separates lease components and service components of a contract, and applies the lease accounting requirements only to the lease components.

The Group is in the process of making an assessment of the potential impact of application of HKFRS 16, the directors consider that it is not practicable to provide a reasonable estimate of the effect of the adoption of HKFRS 16 until the Group performs a detailed review.

The amended Rules Governing the Listing of Securities on the GEM of the Stock Exchange (the "Amended GEM Listing Rules") in relation to the presentation and disclosures in financial statements, including the amendments with reference to the Hong Kong Companies Ordinance, Cap. 622, apply to the Company in this financial year.

The directors consider that there is no impact on the Group's financial position or performance, however the Amended GEM Listing Rules impacts on the presentation and disclosures in the consolidated financial statements. For example, the statement of financial position of the Company is now presented in the notes to the financial statements rather than as a primary statement and related notes to the statement of financial position of the Company are generally no longer presented.

3. Basis of preparation

(a) Basis of compliance

The consolidated financial statements have been prepared in accordance with all applicable HKFRSs, HKASs and Interpretations (hereinafter collectively referred to as "HKFRS") and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, the financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the GEM of the Stock Exchange.

(b) Basis of measurement

The financial statements have been prepared under the historical cost basis.

(c) Functional and presentation currency

The financial statements are presented in Hong Kong Dollars ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

(a) Basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiaries. Inter-company transactions and balances between group companies together with unrealised profits are eliminated in full in preparing the consolidated financial statements. Unrealised losses are also eliminated unless the transaction provides evidence of impairment on the asset transferred, in which case the loss is recognised in profit or loss.

The results of subsidiaries acquired or disposed of during the year are included in the consolidated statement of comprehensive income from the dates of acquisition or up to the dates of disposal, as appropriate. Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with those used by other members of the Group.

(b) Subsidiaries

A subsidiary is an investee over which the Company is able to exercise control. The Company controls an investee if all three of the following elements are present: (i) power over the investee, (ii) exposure, or rights, to variable returns from the investee, and (iii) the ability to use its power to affect those variable returns. Control is reassessed whenever facts and circumstances indicate that there may be a change in any of these elements of control.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment losses, if any. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

(c) Associates

An associate is an entity over which the Group has significant influence and that is neither a subsidiary nor a joint arrangement. Significant influence is the power to participate in the financial and operating policy decisions of the investee but not control or joint control over those policies.

Associates are accounted for using the equity method whereby they are initially recognised at cost and thereafter, their carrying amount are adjusted for the Group's share of the post-acquisition change in the associates' net assets except that losses in excess of the Group's interest in the associate are not recognised unless there is an obligation to make good those losses.

Profits and losses arising on transactions between the Group and its associates are recognised only to the extent of unrelated investors' interests in the associate. The investor's share in the associate's profits and losses resulting from these transactions is eliminated against the carrying value of the associate. Where unrealised losses provide evidence of impairment of the asset transferred they are recognised immediately in profit or loss.

Any premium paid for an associate above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the associate. Where there is objective evidence that the investment in an associate has been impaired, the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

(c) 聯營公司

聯營公司為一間本集團對其擁有重大影響力而並非屬附屬公司或共同安排的實 體。重大影響力乃有權參與被投資方之 財務及經營政策決定之權力,但並非控 制或共同控制該等政策。

(d) Joint arrangements

The group is a party to a joint arrangement where there is a contractual arrangement that confers joint control over the relevant activities of the arrangement to the group and at least one other party. Joint control is assessed under the same principles as control over subsidiaries.

The group classifies its interests in joint arrangements as either:

- Joint ventures: where the group has rights to only the net assets of the joint arrangement; or
- Joint operations: where the group has both the rights to assets and obligations for the liabilities of the joint arrangement.

In assessing the classification of interests in joint arrangements, the Group considers:

- The structure of the joint arrangement;
- The legal form of joint arrangements structured through a separate vehicle;
- The contractual terms of the joint arrangement agreement; and
- Any other facts and circumstances (including any other contractual arrangements).

The Group accounts for its interests in joint ventures in the same manner as investments in associates (i.e. using the equity method – see note 4(c)).

Any premium paid for an investment in a joint venture above the fair value of the Group's share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the investment in joint venture. Where there is objective evidence that the investment in a joint venture has been impaired the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

The Group accounts for its interests in joint operations by recognising its share of assets, liabilities, revenues and expenses in accordance with its contractually conferred rights and obligations.

Property, plant and equipment, other than construction in progress ("CIP") are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to the working condition and location for its intended use. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other costs, such as repairs and maintenance are charged to the profit or loss during the period in which they are incurred.

Depreciation on property, plant and equipment other than CIP is provided over their estimated useful lives, using the straight line method. The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted, if appropriate, at each reporting date. The estimated useful lives are as follows:

CIP, which is stated at cost less impairment losses, representing lighting systems pending installation as well as cost incurred during the periods of installation and testing. CIP is reclassified to the appropriate category of property, plant and equipment when completed and ready for use. No depreciation is provided for in respect of construction in progress until it is completed and ready for its intended use.

(f) Revenue recognition

Revenue from sales of goods is recognised on transfer of risks and rewards of ownership, which is at the time of delivery and the title is passed to customer.

Leasing service income consists of:

- (i) operating lease rental income and is recognised on a time proportion basis over the period of lease term; or
- (ii) finance lease income and is recognised over the period of lease using the effective interest method.

Consultancy and management service income is recognised when services are rendered.

Interest income is accrued on a time basis on the principal outstanding at the applicable interest rate.

(g) Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to lessee. All other leases are classified as operating leases.

The Group as lessor

Amounts due from lessees under finance leases are recorded as receivables at the amount of the Group's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment outstanding in respect of the leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

The Group as lessee

Assets held under finance leases are initially recognised as assets at their fair value or, if lower, the present value of the minimum lease payments. The corresponding lease commitment is shown as a liability. Lease payments are analysed between capital and interest. The interest element is charged to profit or loss over the period of the lease and is calculated so that it represents a constant proportion of the lease liability. The capital element reduces the balance owed to the lessor.

The total rentals payable under the operating leases are recognised in profit or loss on a straight-line basis over the lease term. Lease incentives received are recognised as an integrated part of the total rental expense, over the term of the lease.

(ii) Impairment

At the end of the reporting periods, the Group reviews the carrying amounts of its intangible assets to determine whether there is an indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of an asset is estimated in order to determine the extent of the impairment loss, if any. If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised as an expense immediately.

When an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised as an income immediately.

Inventories are initially recognised at cost, and subsequently at the lower of cost and net realisable value. Cost comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition. Cost is calculated using the weighted-average basis. Net realisable value represents the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sale.

(j) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and in hand, form an integral part of the Group's cash management.

(k) Financial Instruments

(i) Financial assets

The Group classifies its financial assets at initial recognition, depending on the purpose for which the asset was acquired. Regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. A regular way purchase or sale is a purchase or sale of a financial asset under a contract whose terms require delivery of the asset within the time frame established generally by regulation or convention in the marketplace concerned.

Loans and receivables

These assets are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They arise principally through the provision of goods and services to customers (trade debtors), and also incorporate other types of contractual monetary asset. Subsequent to initial recognition, they are carried at amortised cost using the effective interest method, less any identified impairment losses.

The Group assesses, at the end of each reporting period, whether there is any objective evidence that financial asset is impaired. Financial asset is impaired if there is objective evidence of impairment as a result of one or more events that has occurred after the initial recognition of the asset and that event has an impact on the estimated future cash flows of the financial asset that can be reliably estimated. Evidence of impairment may include:

- significant financial difficulty of the debtor;
- a breach of contract, such as a default or delinquency in interest or principal payments;
- granting concession to a debtor because of debtor's financial difficulty;
- it becoming probable that the debtor will enter bankruptcy or other financial reorganisation.

For loans and receivables

An impairment loss is recognised in profit or loss and directly reduces the carrying amount of financial asset when there is objective evidence that the asset is impaired, and is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the original effective interest rate. The carrying amount of financial asset is reduced through the use of an allowance account. When any part of financial asset is determined as uncollectible, it is written off against the allowance account for the relevant financial asset.

The effective interest method is a method of calculating the amortised cost of a financial asset or financial liability and of allocating interest income or interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts or payments through the expected life of the financial asset or liability, or where appropriate, a shorter period.

(v) Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

Any transaction costs associated with the issuing of shares are deducted from share premium, net of any related income tax benefit, to the extent that they are incremental costs directly attributable to the equity transaction.

(vi) Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument. A financial guarantee contract issued by the Group and not designated as at fair value through profit or loss is recognised initially at its fair value less transaction costs that are directly attributable to the issue of the financial guarantee contract. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of: (i) the amount determined in accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets"; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation recognised in accordance with HKAS 18 "Revenue".

The Group derecognises a financial asset when the contractual rights to the future cash flows in relation to the financial asset expire or when the financial asset has been transferred and the transfer meets the criteria for derecognition in accordance with HKAS 39.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires.

(I) Income taxes

Income taxes for the year comprise current tax and deferred tax.

Current tax is based on the profit or loss from ordinary activities adjusted for items that are non-assessable or disallowable for income tax purposes and is calculated using tax rates that have been enacted or substantively enacted at the end of reporting period.

Deferred tax is recognised in respect of temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the corresponding amounts used for tax purposes. Deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised. Deferred tax is measured at the tax rates expected to apply in the period when the liability is settled or the asset is realised based on tax rates that have been enacted or substantively enacted at the end of reporting period.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, associates and jointly controlled entities, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

Income taxes are recognised in profit or loss except when they relate to items recognised in other comprehensive income in which case the taxes are also recognised in other comprehensive income.

(m) Foreign currency

Transactions entered into by the group entities in currencies other than the currency of the primary economic environment in which they operate (the "functional currency") are recorded at the rates ruling when the transactions occur. Foreign currency monetary assets and liabilities are translated at the rates ruling at the end of the reporting period. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the translation of monetary items, are recognised in profit or loss in the period in which they arise. Exchange differences arising on the retranslation of non-monetary items carried at fair value are included in profit or loss for the period except for differences arising on the retranslation of non-monetary items in respect of which gains and losses are recognised in other comprehensive income, in which case, the exchange differences are also recognised in other comprehensive income.

All assets and liabilities of foreign operations are translated at the rate ruling at the end of reporting period. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity as foreign exchange reserve (attributed to minority interests as appropriate). Exchange differences recognised in profit or loss of group entities' separate financial statements on the translation of longterm monetary items forming part of the Group's net investment in the foreign operation concerned are reclassified to other comprehensive income and accumulated in equity as foreign exchange reserve.

(n) Employee benefits

Short term employee benefits

Short term employee benefits are employee benefits (other than termination benefits) that are expected to be settled wholly before twelve months after the end of the annual reporting period in which the employees render the related service. Short term employee benefits are recognised in the year when the employees render the related service.

Defined contribution

Contributions to defined contribution retirement plans are recognised as an expense in profit or loss when the services are rendered by the employees.

Borrowing costs attributable directly to the acquisition, construction or production of qualifying assets which require a substantial period of time to be ready for their intended use or sale, are capitalised as part of the cost of those assets. All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(q) Provisions and contingent liabilities

In addition to information disclosed elsewhere in these financial statements, other key sources estimation uncertainty that have a significant risk of resulting a material adjustment to the carrying amounts of assets and liabilities within next financial period are as follows:

(i) Net realisable value of inventories

Net realisable value of inventories is the estimated selling price in the ordinary course of business, less estimated costs of completion and selling expenses. These estimates are based on the current market condition and the historical experience of selling products of similar nature. It could change significantly as a result of competitor actions in response to severe industry cycles. Inventory value is reduced when the decision to markdown below cost is made. Management reassesses the estimations at the reporting date. The carrying amount of inventories is disclosed in note 19.

(ii) Impairment of trade and other receivables

The Group's management assesses the collectibility of trade and other receivables on a regular basis to determine if any provision for impairment is necessary. This estimate is based on, where appropriate, the evaluation of collectibility and ageing analysis of the receivables and on the management's judgment. A considerable amount of judgment is required in assessing the ultimate realisation of these outstandings, including the current creditworthiness and the past collection history of each debtor. If the financial conditions of the Group's debtors were to deteriorate, resulting in an impairment of their ability to make payments, provision for impairment may be required. Management reassesses the provision for impairment at the reporting date. The carrying amounts of trade and other receivables are disclosed in notes 20 and 21, respectively.

(iii) Impairment of finance lease receivables

When there is objective evidence of impairment loss, the Group takes into consideration the estimation of future cash flows. The amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). Where the actual future cash flows are less than expected, a material impairment loss may arise. The carrying amount of finance lease receivables is disclosed in note 18.

(iv) Depreciation

The Group depreciates property, plant and equipment using straight-line method over the estimated useful lives, starting from the date on which the assets are placed into use. The estimated useful lives reflect the directors' estimate of the periods that the Group intends to derive future economic benefits from the use of the Group's property, plant and equipment. The carrying amount of property, plant and equipment is disclosed in note 14.

(v) Impairment of non-financial assets

The Group assesses at the end of each reporting date whether there is an indication that an asset may be impaired. If any such indication exists, the Group makes an estimate of the recoverable amount of the asset. This requires an estimation of the value-in-use of the cash-generating unit to which the asset is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating unit and also to choose a suitable discount rate in order to calculate the present value of those cash flows. (vi) Warranty provision

The Group generally offers 2-3 years warranty for the lighting products during which free warranty service for the repair and maintenance of parts and components under normal usage is provided to the customers. The warranty provision provided during the year, depending on the product type, was based on the past experience of the failure rate of the products in the warranty service period. The carrying amount of warranty provision is disclosed in note 25.

(vii) Income tax

Determining income tax provisions requires the Group to make judgment on the tax treatment of certain transactions. The Group carefully evaluates tax implications of transactions in accordance with prevailing tax regulations and makes tax provisions accordingly. In addition, deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences can be utilised. This requires significant judgment on the tax treatments of certain transactions and also assessment on the probability that adequate future taxable profits will be available for the deferred tax assets to be recovered. The carrying amount of provision for taxation and deferred tax liabilities are amounted to approximately HK\$7,635,000 (2015: HK\$7,346,000) and HK\$118,000 (2015: HK\$404,000) as at 31 March 2016.

35. Financial risk management objectives and policies

The board of directors meets periodically to analyse and formulate measures to manage and monitor the Group's exposure to market risk including principally changes in interest rates and currency exchange rates, credit risk and liquidity risk. Generally, the Group employs a conservative strategy regarding its risk management. As the Group's exposure to market risks is kept at a minimum level, the Group has not used any derivatives or other instruments for hedging purposes. The Group does not hold or issue derivative financial instruments for trading purposes. The board of the directors of the Company reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group's interest rate risk arises primarily from long-term borrowings. Borrowings issued at variable rates and at fixed rates expose the Group to cash flow interest rate risk and fair value interest risk respectively. The interest rate of the Group's borrowings is disclosed in note 26. The Group adopts centralised treasury policies in cash and financial management and focuses on reducing the Group's overall interest expenses.

The following table details the interest rate profile of the Group's borrowings at the end of the reporting period.

At 31 March 2016, it is estimated that a general increase/decrease of 50 basis points in interest rates, with all other variables held constant, would decrease/increase the Group's results for the year by approximately HK\$126,000 (2015: Nil). No impact would be on other components of consolidated equity in response to the general increase/decrease in interest rates.

The sensitivity analysis above has been determined assuming that the change in interest rates had occurred at the end of reporting period and had been applied to the exposure to interest rate risk for the borrowings in existence at that date. The 50 basis point increase or decrease represents management's assessment of a reasonably possible change in interest rates over the period until the next annual reporting date. The analysis is performed on the same basis for year ended 31 March 2015.

The Group's revenue and expenses are mainly in HK\$ which is the functional currency of all entities making up the Group. As at 31 March 2016, the Group's assets and liabilities denominated in other currencies other than HK\$ are disclosed in notes 18, 20, 23, 24 and 25. The Group currently does not have a foreign currency hedging policy. However, management monitors foreign currency exposure and will consider hedging significant foreign currency exposure should the need arise.

The Group is mainly exposed to the foreign currency risk of RMB, US\$, RM and IDR. As HK\$ is pegged to US\$, the Group does not expect any significant movement in the US\$/HK\$ exchange rate and this is excluded from the sensitivity analysis below as in the opinion of directors, such sensitivity analysis does not give additional value in view of insignificant movement in the US\$/HK\$ exchange rates as at the reporting dates.

Credit risk

The Group enters into trading transaction with the recognised and reputable third parties. Before accepting any new lease contract, the Group assesses the credit quality of each potential lease and might demand certain customers to place deposits with the Group at the time the lease arrangement is entered into. In addition, the Group monitors and controls the trade receivables regularly to mitigate the risk of significant exposure from bad debts, reviews the recoverable amount of each individual trade receivables at each reporting date to ensure that adequate impairment losses are made for irrecoverable amounts. Normally, the Group does not obtain collateral from customers.

The Group has concentration risk upon trade receivables through trading of lighting products contributing from an overseas customer in Australia (the "Australia Customer") during the year.

The Group's revenue derived from the Australia Customer, amounted to approximately HK\$35,999,000 (2015: HK\$22,305,000) which accounted for approximately 28% (2015: 20%) of the Group's total revenue for the year. The corresponding trade receivables contributed approximately HK\$37,872,000 (2015: HK\$15,333,000) which accounted for approximately 45% (2015: 26%) of the Group's trade receivables as at 31 March 2016.

The Group closely monitors the credit risk on individual customers based on their credit worthiness. In addition, the Group has assessments which involve the customer's past payments history and current ability to pay and take into account information specific to customers as well as pertaining to the economic environment in which the customers operate.

Credit risk in cash and cash equivalents is mitigated as cash is deposited in bank of high credit rating.

Fair values

The fair values of the Group's financial assets and liabilities are not materially different from their carrying amounts because of the immediate or short term maturity.
