VOLUNTARY ANNOUNCEMENT
CONSTRUCTION PROJECT OF A SOLAR PHOTOVOLTAIC
POWER GENERATION SYSTEM
WITH AN INSTALLED CAPACITY OF 600 KILOWATT

The board (the “**Board**”) of directors (the “**Directors**”, each a “**Director**”) of Unity Group Holdings International Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) is pleased to announce on a voluntary basis the latest business development of the Company.

On 24 October 2022, Guangzhou Synergy Energy Efficiency Technology Co. Ltd. (廣州先能馳節能科技有限公司), a wholly-owned subsidiary of the Group entered into a contract with Zhuhai Xiangbang Environmental Protection Building Materials Co., Ltd. (珠海祥邦環保建材有限公司) (an independent third party) for the construction of a 600-kilowatt distributed solar photovoltaic power generation system (the “**Project**”) for its plant in Zhuhai of Mainland China, and the Project is expected to generate 660,000 kWh electric power annually (equivalent to a reduction of approximately 386 tonnes of CO₂ equivalent emission annually). The Project is expected to generate revenue of approximately HK\$3 million for the Group.

The Project is expected to be completed and delivered on or before 31 December 2022.
